Information notice on the protection of personal data CRNL Newsletter

1. Identity and contact details of the data controller

The data controller is the Centre de Recherche en Neurosciences de Lyon (CRNL) under the direction of Mr Laurent Bezin (laurent.bezin@cnrs.fr).

2. Purpose of processing

3. Categories of data collected

4. Legal basis for processing

The legal basis for processing is the legitimate interest pursued by the data controller (cf. article 6.1.f of the European Data Protection Regulation).

5. Recipients and data retention period

The personal data collected in the context of this newsletter is intended for the CRNL communication department and is updated annually. You may request the deletion of your data at any time. In the event of a request to unsubscribe, the data will be deleted on receipt of the request from the person concerned.

6. Your rights

In accordance with the provisions of the French Data Protection Act (Act of January 6, 1978 as amended), European Regulation 2016/679 of April 27, 2016, you have the following rights with regard to the use made of your data:

- The right to object: you may at any time object to the processing of your data and have the right to withdraw your consent.
- The right to access and rectify your data
- The right to erasure
- The right to restricted use of your data when it is no longer necessary or useful.
